

Donor Return - Gifts to Relevant Entities

- Part 1 of this return is to be completed by a person:
 - who made a gift/gifts with amounts or values totalling more than \$5000 to a relevant entity; or
 - who made a gift/gifts to another person or body with the intention of benefitting a particular relevant entity.
- Part 2 of this return must be completed if the person received (at any time) any gifts of more than \$5000 that the person used during the period either wholly or partly:
 - o to make a gift to a relevant entity (disclosed in Part 1); or
 - o as reimbursement for making a gift to a relevant entity (disclosed in Part 1).
- A relevant entity is a registered political party, associated entity or third party.
- This form is to be completed in accordance with section 130ZH of the Electoral Act 1985 and the associated regulations.
- The information in this return will be made available for public inspection.

This form is for reporting donations to <u>relevant entities only</u>. Please use the form 'Donor Return-Gifts or Loans to Candidate or Group' for donations made to candidates or groups.
